## Terms and Conditions

1. Subject to the remainder of these terms and conditions customers can claim the cash back amount on the qualifying HP Scanjet Scanners purchased between 1 August and 31 October 2009. Customers may claim cash back for a maximum of 10 qualifying HP Scanjet Scanners during the period of the promotion.
2. To take advantage of the promotion, customers must print out and complete the claim form (which can be downloaded at [www.hp.com/uk/savemoney](http://www.hp.com/uk/savemoney)) and send it, along with proof of purchase in the form of the seller's invoice, to the address set out in the claim form. Proof of order or dispatch note will not be accepted. The seller's invoice must clearly show the customer details, HP part codes of the qualifying products purchased, the purchase price and the date of purchase. The participant must not send original receipts. HP must receive the claim form within 30 days from the date of purchase.
3. The promotion is valid in respect of qualifying products purchased either directly from HP or an authorised reseller or authorised retailer of HP. The promotion is only valid for end user customers (i.e. customers purchasing products for their own use); claims where the products purchased will be resold or rented to a third party are ineligible for this promotion.

Once the claim has been received and approved, the participant will receive confirmation of receipt of the claim form by email from [savemoney@out-bound.co.uk](mailto:savemoney@out-bound.co.uk), within seven days of sending the claim.
